PARTNERS VALUE SPLIT CORP. ANNOUNCES 2016 SEMI-ANNUAL RESULTS

TORONTO, August 26, 2016 – Partners Value Split Corp. (the “Company”) announced today that the net asset value per unit was \$105.09 at June 30, 2016.

Income available for distribution for the six month period ended June 30, 2016 was \$27 million compared to \$23 million in the prior year. Net asset value per unit consists of one preferred share and one capital share. The net asset value per unit is posted monthly on our website at www.partnersvaluesplit.com.

Brookfield is a global alternative asset manager with over a 100-year history of owning and operating assets with a focus on property, renewable energy, infrastructure and private equity. Brookfield is co-listed on the New York and Toronto Stock Exchanges under the symbol BAM and BAM.A, respectively, and on NYSE Euronext under the symbol BAMA.
