PARTNERS VALUE SPLIT CORP. ANNOUNCES 2018 SEMI-ANNUAL RESULTS

TORONTO, August 22, 2018 – Partners Value Split Corp. (the "Company") announced today that the net asset value per unit was USD\$96.83 at June 30, 2018. All amounts are stated in US dollars.

Income available for distribution for the period ended June 30, 2018 was \$24 million compared to \$30 million in the prior year. The decrease in investment income during the period is a result of the spin-off of Trisura Group Ltd. ("Trisura") from Brookfield Asset Management Inc. ("Brookfield"), being recognized as a dividend in 2017.

Net asset value per unit consists of one preferred share and one capital share. The net asset value per unit is posted monthly on our website at www.partnersvaluesplit.com.

Brookfield is a global alternative asset manager with over a 100-year history of owning and operating assets with a focus on property, renewable energy, infrastructure and private equity. Brookfield is co-listed on the New York and Toronto Stock Exchanges under the symbol BAM and BAM.A, respectively, and on NYSE Euronext under the symbol BAMA.
